ESSENTIAL JOB FUNCTIONS:

This is routine manual labor and equipment operation activities involved in the maintenance, operation, installation, construction, and repair of the city's water distribution and sewage collection facilities. Work involves responsibility for performance of a variety of heavy and light manual tasks. Assignments may include the use of standard or specialized hand tools, power-operated devices, or other equipment. Operates and/or maintains water systems including water storage reservoirs, water mains, valves, fire hydrants, and pumps. Responds to emergency calls and inspects system for leaks or back-up and determines corrective action. Operates and/or maintains storm and sanitary sewer systems, including lift stations, storm water ponds, sewer mains, manholes, generators, catch basins, and pumps. Locates and marks underground utilities as requested by contractors and property owners. Assignments also include the operation of trucks and other automotive or construction equipment incidental to regular duties. Position is subject to call backs, unscheduled overtime, shift work, and weekend duty.
